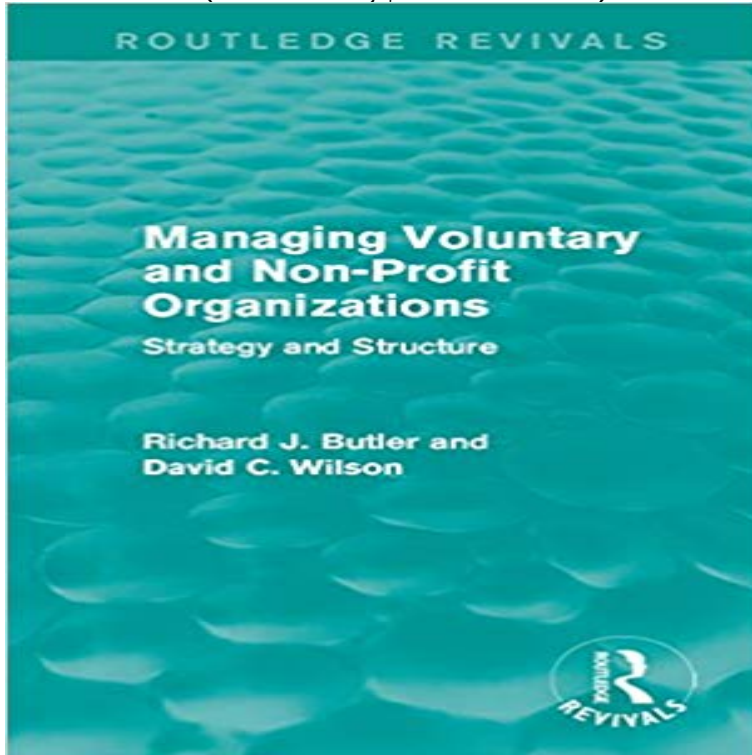


# Managing Voluntary and Non-Profit Organizations: Strategy and Structure (Routledge Revivals)
