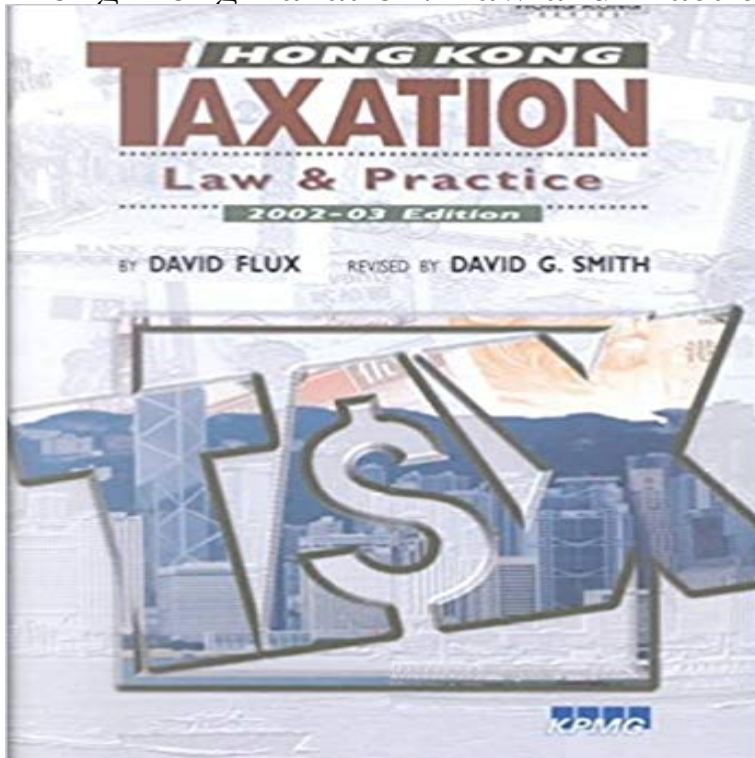


Hong Kong Taxation: Law and Practice
