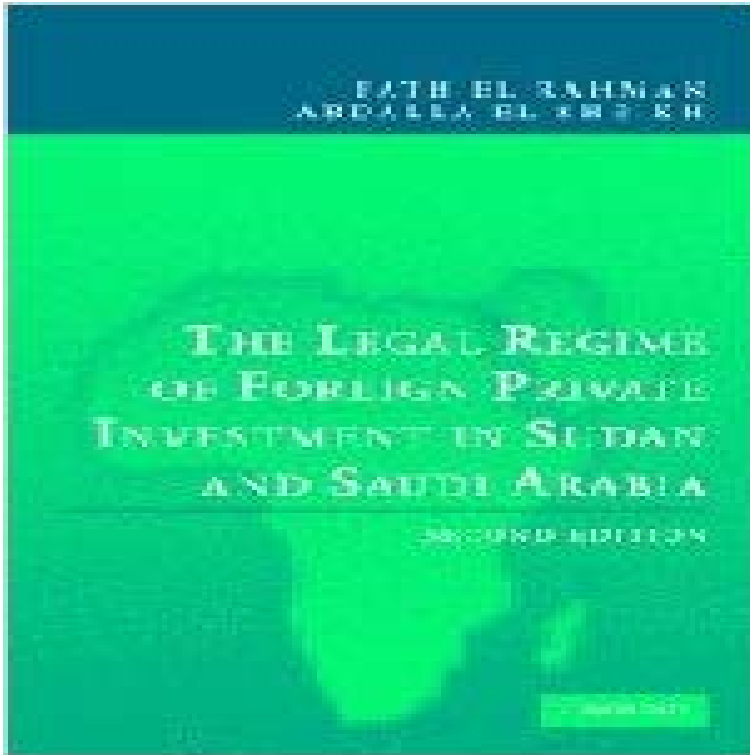


The Legal Regime of Foreign Private Investment in Sudan and Saudi Arabia
