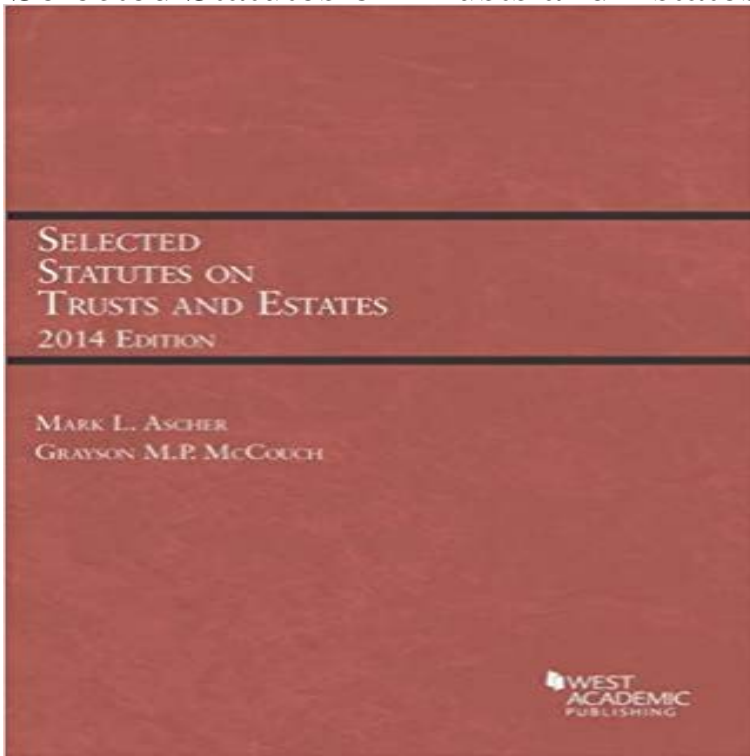


## Selected Statutes on Trusts and Estates, 2014
